User Licensing and Use Case. Schedule A specifies the number of Authorized Users. Where Schedule A states that an organizational license applies, the number of Authorized Users is unlimited (subject to ICIS reasonable system limitations from time to time). Unless otherwise stated on this Order Form, Authorized Users are individual, natural persons based at the locations identified on this Order Form. Authorized Users may (a) access and use the Product and/or Licensed Content in accordance with Part B of the Terms and this Order Form in order to undertake the relevant Use Case activities, as set out in Schedule A and (b) may create and share Derived Data internally on an incidental and non-systematic basis and solely as required in order to undertake the relevant Use Case activities. Nothing in this section permits external sharing of Licensed Content. Fair usage limits apply.

Data as a Service Right. Where Schedule A includes the DaaS right, Customer may (a) receive Licensed Content via an API or other delivery method set out on this Order Form, (b) scrape Licensed Content from the Product, (c) download Licensed Content using download functionality within the Product, and/or (d) download Licensed Content using the ICIS Excel Plug-In, and may input Licensed Content in the Permitted Applications, solely within the scope of the license granted in this Order Form and in order to make Licensed Content available to Authorized Users to undertake the relevant Use Case activities (as set out in Schedule A). Fair usage limits apply. Nothing in this Order Form permits use of Licensed Content in conjunction with generative AI technology, and Customer warrants that Permitted Applications do not incorporate generative AI functionality. Retrieval Augmented Generation (RAG) Right. Where Schedule A includes the DaaS with RAG right, Customer may maintain a private, closed, generative AI application (a Permitted Application) for internal use by Authorized Users. LNRS agrees that Customer may, within the parameters of this license, store Licensed Content within its internal systems and may make such Licensed Content available for use as a retrieval augmented generation (RAG) data store in the context of the Permitted Application, provided that during the Term: (a) the Permitted Application is maintained and used in a closed hosted environment solely for internal use by Authorized Users in accordance with this Order Form, and (b) Licensed Content is not made available to a third party or used to train a large language model. If Schedule A does not include the DaaS right, the rights in this paragraph do not apply.

ICIS Energy Price History Terms. In relation to ICIS Hindsight and ICIS Foresight, Customer may retain ICIS historical data (“Historical Data”) during the Term for so long as Customer maintains a continuous subscription for the commodity to which the Historical Data relates. In relation to ICIS Insight, ICIS energy historical data (“Historical Data”) is licensed on a one-year rolling basis, and Customer agrees to delete Historical Data on a rolling basis so that Customer does not at any point during the Term hold Licensed Content relating to a date which is more than one year prior to the present (i.e. does not build up a store of Historical Data which extends more than one year into the past).

PERMITTED ACTIVITIES

Each level includes the use cases for the preceding levels. Contracting includes all of the Base use cases, and Financial Trading includes the Contracting and Base use cases.

FINANCIAL TRADING.

Derivative Trading/Hedging: Authorized Users may use Licensed Content to formulate a trading and hedging strategy (typically trading SWAPS, futures and options).

CONTRACTING -

Invoicing/Settlement: Authorized Users may use Licensed Content to produce, check, and validate settlement of invoices or payments in connection with contracts.

Trading with Settlement: Authorized Users may use Licensed Content to conduct settlements in physical or cash settled contracts. This includes using Licensed Content to produce, check, and validate settlement of invoices or payments in connection with contracts. This excludes trading for hedging or risk management purposes.

BASE
